Do not include too many tables. Try to combine these wherever possible. Use Arabic numerals for the table and figure numbers, these should be carefully planned to fit the production size of printed page.
- **References:** For references at the end follow APA/ ILI/ BLUE BOOK Style.
- **Offprint:** An offprint of paper/article should be sent in MS-Word and in times new roman with font size 12 in double space and should be printed on one side of A4 paper.
